## Terms and conditions

## CONDITIONS OF REGISTRATION

- 1. By registering my child on a CRU Camp, I agree to permit the use of photographs and videos, or other pictures of applicant camper, in promoting Crusaders' activities and programs. (For exceptions call (02) 9874 8933).
- 2. By registering my child on a CRU camp, I consent to Crusaders disclosing my child's name, contact information and feedback to the Crusader contact person at my child's school and to a local church's kids/youth group.
- 3. All registrations require full payment in order to be accepted (except ski and schoolies camps). Payment can be made by cash, cheque or credit card.
- 4a. Ski camps require either full payment or a deposit. The balance must be paid no later than 21 days prior to the camp commencing or the camper's place will be forfeited and the deposit (less a \$50 administration charge) refunded. 4b. Schoolies camps require either full payment or a non-refundable deposit of \$250. The balance must be paid no later than 6 weeks prior to the camp commencing or the camper's place and the deposit amount will be forfeited.
- 5. Online registration requires payment by credit card. Online transactions are processed through a secure gateway and no credit card details are collected or stored by Crusaders. An online registration is confirmed only when a confirmation email and receipt from Crusaders is received by the applicant stating that the registration was successful.

  6. It is possible to make an online registration from the Crusader stating that the Crusader stating that the Crusader stating that the registration was successful.
- 6. It is possible to make an online registration for a child for whom you are not parent or legal guardian. However, that child's parent or legal guardian must post or fax a signed authorisation form to the Crusader office within 5 working days of receipt of the form, or Crusaders reserves the right to cancel and reallocate the booking. The camp fee (less a \$50 administration charge) will be refunded to the payee.
- 7. Phone bookings are accepted and require payment by credit card. The medical and authorisation information must be received in the Crusader office within 48 hours of the phone booking date or Crusaders reserves the right to cancel and reallocate the booking. Cancellation fees apply.

  8. Except schoolies camps, cancellations made up to 28 days prior to the commencement of a camp will receive a refund less an administrative charge of \$50. Except ski and schoolies camps, cancellations made between 28 days & 7 days prior to the camp will incur a cancellation fee of \$50% of the camp fee. Cancellations made within 7 days of the camp will incur a charge of 100% of the camp fee. Where possible, Crusaders will endeavour to refund some of the camp fee.
- 9a. Ski camp cancellations made between 28 days & 14 days prior to the camp will incur a cancellation fee of 50% of the camp fee. Cancellations made within 14 days of the start of camp will incur a cancellation fee of 100% of the camp fee.
- 9b. Schoolies camp cancellations made within 6 weeks of the camp will incur a cancellation fee of 100% of the camp fee.
- 10. A \$50 penalty applies on transferring between camps, within a season. Transfers are not permitted within 14 days of the original camp start date. Transfers are not permitted for schoolies camps.
- $11. \ Refunds \ will \ not \ be \ given \ for \ partial \ attendance.$
- 12. All CRU Holiday Camp fees are GST free. Prices for merchandise/gear are GST inclusive.
- 13. Merchandise purchased online will be delivered to the camper at the applicable camp. Postage charges will apply if this is not possible.
- 14. All service and product prices are listed and all transactions processed in AU\$.
- 15. All camps must meet a minimum number in order to run. If the minimum is not reached and Crusaders cancels the camp, then a full refund will apply.
- 16. Camp details are subject to change without notice.
- 17. Whilst applications will be accepted in the order of their arrival, Crusaders reserves the right to accept or reject any booking.
- 18. Crusaders runs all sail and canoe activities under NSW Waterways Hire & Drive licence number HD0455.
- 19. Earlybird discounts, where offered, apply only when full payment is received with registration.

## **AUTHORISATION STATEMENT**

I agree to the Terms and Conditions of booking outlined above and to my son/daughter attending the camp on this understanding. I understand that Crusaders do not permit the use of alcohol, non-prescribed drugs or smoking on camps and that anyone found in breach of this can expect to be sent home immediately. I have communicated this information to my child.

I understand that although The Crusader Union of Australia attempts to minimise any risk of personal injury, all physical activities carry risks that may result in personal injury or death to the participant and that accidents may occur. I acknowledge that personal injury is an inherent risk within the activities undertaken as a part of this program. I have read and understand the individual risks of activities being conducted as stated at www.crusaders.edu.au/cru-holiday-camps/risk-warning/

If my child's registration form indicates that they suffer from a potentially critical allergy/medical condition, I authorise for this information to be printed on their identification tag. In the event of accident or illness, I authorise the Camp Director to consent, where it is impracticable to communicate with me, to my son/daughter receiving any x-ray examination, anaesthetic, medical, surgical or hospital treatment as may be deemed necessary by a licensed physician and/or surgeon. I also authorise to engage such treatment and agree to pay the appropriate fees for such service and treatment.

I agree to meet the expense of my son/daughter being returned home to my home, either by the director or leader accompanying him/her and then rejoining the group or by collecting him/her personally. I understand that such an arrangement may be necessary due to illness, injury, or if, in the opinion of the Camp Director, non-cooperation of any description or the inability to meet the rigours and requirements of the activity by my son/daughter.

I agree to meet the expense of any damages to property or equipment caused by my son/daughter while on camp. I agree to my son/daughter attending the camp on this understanding.
